South Orange Downtown Facade Improvement Grant Program Guidelines

The South Orange Downtown Special Improvement District (SID) is funding a facade grant program to assist small businesses and property owners located within the SID boundaries with performing façade improvements to their storefronts. The South Orange Downtown Facade Improvement Grant Program is intended to support and encourage small businesses to reinvest in the downtown business district.

The facade program recognizes the positive impact that individual building improvements can have on the overall appearance, quality and vitality of the downtown business district. The goal is to help small businesses and property owners rehabilitate and enhance their storefronts by providing an incentive grant that covers 75% of the cost of eligible improvements with a maximum grant allowance of \$2,000 per applicant.

APPLICANTS MUST:

- Own a small business or property within the SID
- Secure funding to pay for the total project cost up front, prior to reimbursement
- Must have at least three years left on their lease agreement
- Complete and submit the application form with required attachments
- Demonstrate commitment to program requirements and design guidelines.

ELIGIBLE PROJECTS

Exterior work (including painting) that significantly improves the appearance of facades and other visible sections of building exteriors.

Business signage, awnings, exterior lighting, and other additions or improvements that add to the visible exterior appeal of retail, service, office, and other non-residential buildings



Interior improvements that enhance the visual appeal of building exteriors, such as storefront-window displays

Upgrades that include new lighting that will both enhance a building's exterior appearance after dark and brighten the downtown streetscape

SELECTION CRITERIA

- **Need-** Priority will be given to storefronts in extreme disrepair.
- Impact- Clusters of 3-5 adjacent businesses will be considered priority projects.
 The clustering effect has the biggest visual impact.
- Capacity: Applicants must be able to pay for the total project cost up front as well
 as adhere to project deadlines and requirements.

HOW IT WORKS

Application Period- Applications will be reviewed on a rolling basis. Submit your completed application form and required attachments via email to melissa@southorangedowntown.org. No applications will be accepted for retroactive projects.

Review & Selection- Applications will be evaluated based on the selection criteria (*see section heading "Selection Criteria"*). You will be notified within 4 weeks if your application has been selected to move forward. An award letter will be issued by South Orange Downtown.

Contract Execution- Upon approval, you will meet with South Orange Downtown to finalize the scope of work and project design. You will submit detailed estimates, with shop drawings if applicable, from at least two licensed and insured contractors. You will have to sign a contract agreeing to follow the program requirements. The contract will include the detailed project scope, grant amount, and contractor information.



Construction- Work with your contractor(s) to begin and complete your project as soon as possible but no later than 60 days after the contract is signed. If needed, program staff can help you find qualified contractors.

GRANT AWARD

The program provides reimbursement grants and payment will be made upon satisfactory completion of projects. Grantees will be reimbursed up to 75% of the total cost of improvements with a maximum grant of \$2,000. For example:

Total Project Cost: \$2,000

75% Grant: \$1,500

Cost to applicant: \$500

Total Project Cost: \$5,000

75% Grant (\$2,000 max): \$2,000

Cost to applicant: \$3,000

South Orange Downtown will make regular site visits to monitor progress and ensure compliance with the agreed-upon design and scope of work. **Projects that do not comply with the agreed-upon scope of work will not be reimbursed.**

All receipts submitted within 30 days of project completion date. Your reimbursement payment will be processed within 14 days of receipt(s) submission for completed work.
